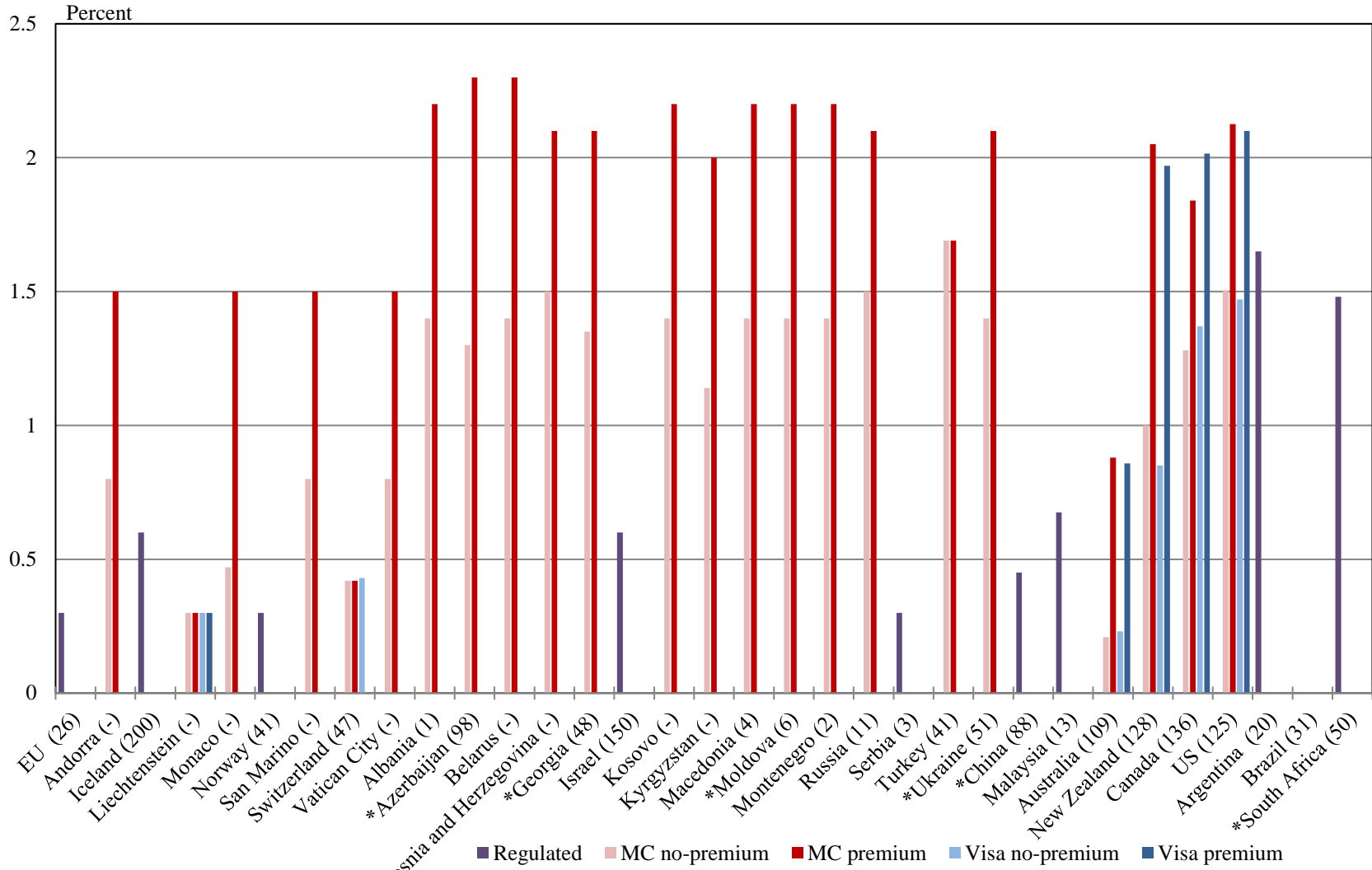

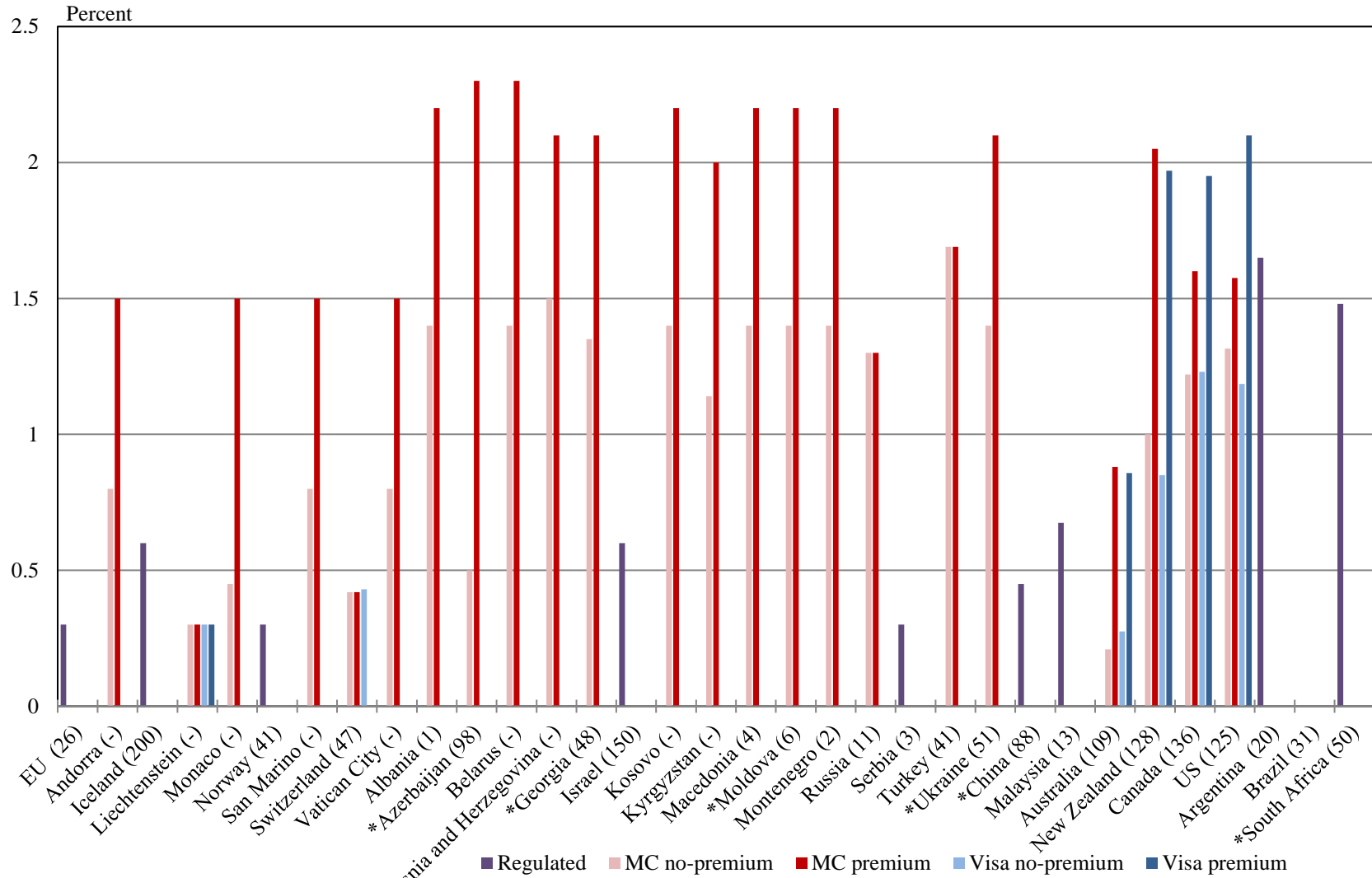

2019 Credit IF Rates: Retail (Face-to-Face)



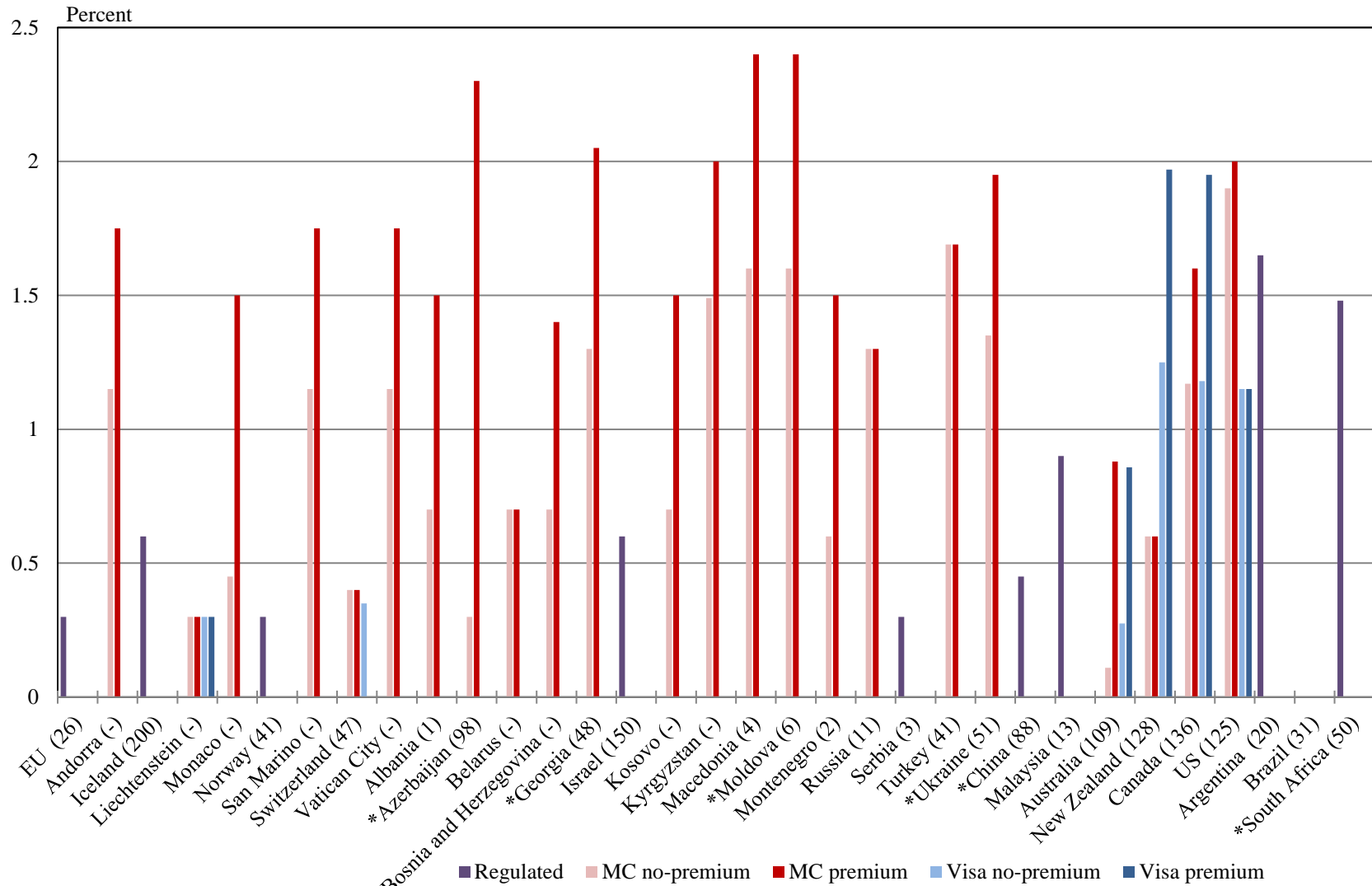

2019 Credit IF Rates: Grocery



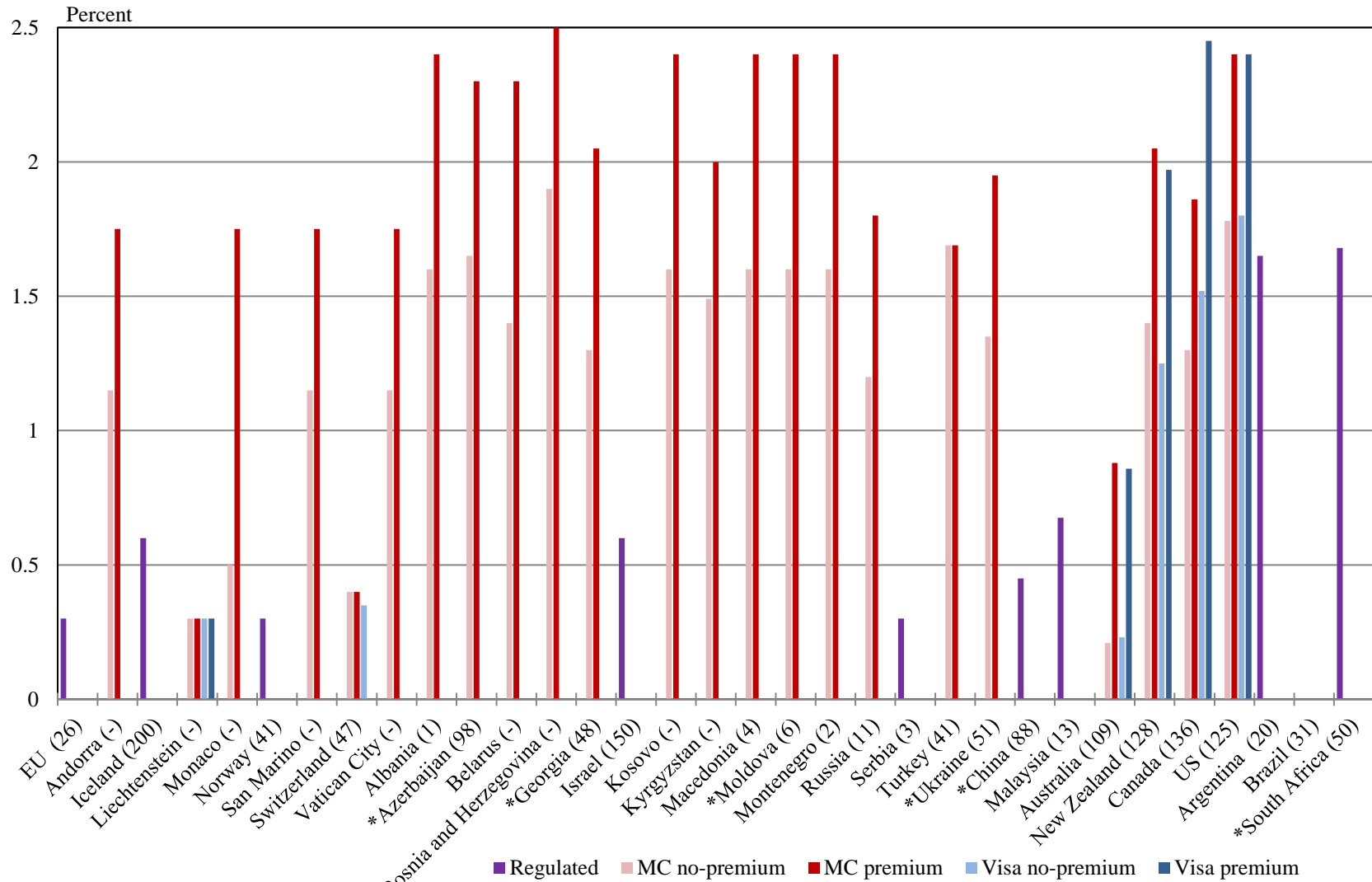

2019 Credit IF Rates: Gas



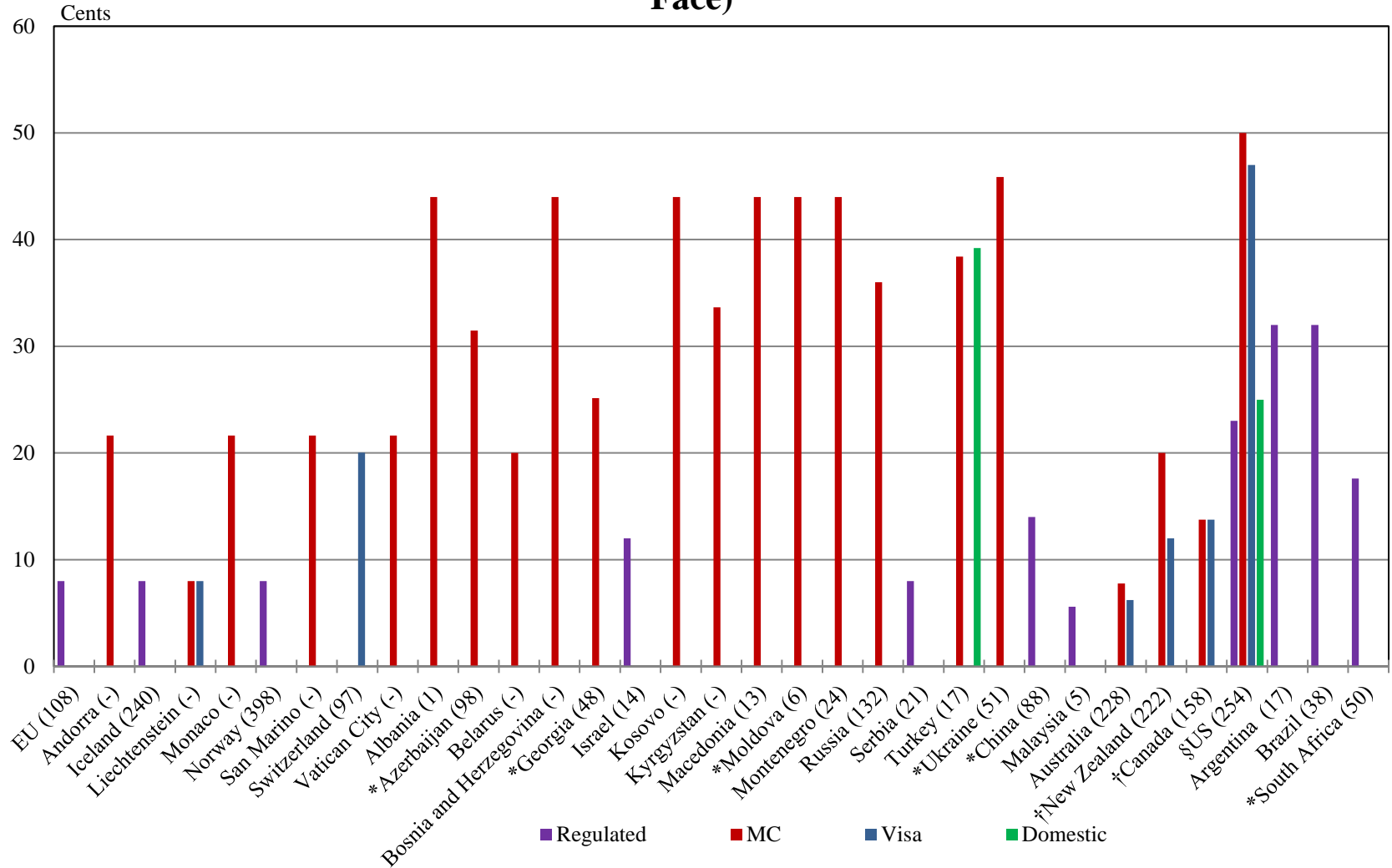

Notes:

The 2019 average exchange rates are used to convert debit card interchange fees for all countries except for Iceland, Albania, Azerbaijan, Belarus, Bosnia and Herzegovina, Georgia, Macedonia, Moldova, Serbia, and Ukraine (2018 averages).

As for Mastercard interchange fees, Maestro fees are used for European countries.

As for the U.S. domestic interchange fee, the average PIN debit interchange fee for exempt issuers reported by the Federal Reserve Board is used.

EU countries are: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Spain, Sweden, and the United Kingdom.

Credit and debit transactions are from 2017 for all countries except Macedonia (2011) and Israel (2018).
